You were kind enough to change the time to 6 and then they didn't attend. We have a group that just doesn't show interest when we asked them again today. I'm thinking we should hold off a couple months until we have some turnover in clients that are willing to participate again. I just don't want to have others come here for no turn out."
- ➤ Therefore, for the time being, Jefferson County Intergroup will be returning to our original schedule of one meeting per week in each facility: Wednesdays @ 7pm, Credo Farm, Evans Mills Fridays @ 7pm, Credo Women's Residence, Watertown
