### **OLD BUSINESS:**

- Dawn N., chair of the ad hoc Committee on JCI Guidelines updating and revision presented a slide show to the JCI tonight.
- She began her presentation with examples of guideline handbooks from other Intergroups. She highlighted the fact that all of these are quite different with some having the organizational structure written into the functional description of each element of the group's guidelines whereas other Intergroups (such as ours) have generated a more formal document with explicit delineation of each element and function of the Intergroup.

- Dawn N. had specific questions to be answered tonight by the Intergroup concerning the content of the PURPOSE section guidelines and explained that the JCI members will be presented with elements of the section that the committee recommends be updated or changed and then will be asked to vote the changes either up or down. She anticipates that this general procedure may be repeated at each future monthly JCI business meeting until we work our way through our guidelines and revise them.
- 1. Recommend that there be the least amount of formatting changes throughout the guideline document. The JCI agreed by consensus with this recommendation
- 2. Strike "local telephone directory listing for the Intergroup" from Purpose 2. The JCI agreed by consensus with this recommendation
- 3. Eliminate Purpose 4. as written, as this is a function of the Literature Committee of the JCI. The JCI agreed with this change by consensus.
- 4. Strike out from Purpose 5. "about alcoholism and" so that these reads: "seeking information about Alcoholics Anonymous". The JCI agreed with this change by consensus.
- 5. Strike from Purpose 10 "not inconsistent" and replace with "consistent". The JCI agreed with this change by consensus.
  - Dawn N. distributed copies of A.A. Guidelines for Central or Intergroup
     Offices to JCI members for their review so that we can be well informed as
     the JCI makes these updates to our Guidelines.

### **NEW BUSINESS:**

- Franklin H., GSR of the Black River Group and a guest at tonight's meeting, presented information that he has been developing on Service Sponsorship.
- Franklin handed out pages of information on Service Sponsorship taken from AA pamphlet #15 on Sponsorship. He asked JCI members to review this information in order to be able to present background on this project when our members are announcing it at meetings.
- Franklin has produced a handout "SEEKING SERVICE SPONSORS" that should be
  available and announced at all our meetings. This document will explain to prospective
  Service Sponsors the information that Franklin is seeking. He is requesting that it be
  distributed and announced at home groups within District 0700. Franklin also
  produced an application form so that prospective Service Sponsors can fill this out and
  thus provide their credentials to those A.A. members seeking Service Sponsorship.
  Franklin will maintain each application and keep a list of sponsors as more interest in
  this project is generated.
- JCI members thanked Franklin for this effort.
